This is vital especially when there is no available surveillance footage at the scene of the accident. If surveillance video footage is available, that would actually be the best but if there is none, observations by witnesses may serve as a substitute. It is thus very important to provide the personal injury attorney with as much information as possible.

It is also important to note that coming up with an auto accident claim is a complicated procedure and may involve a lot of complications. Once Kenneth S. By filing an auto accident claim, those who sustained injuries as a result of the accident will be able to get compensated for their expenses in getting treatment for their injuries and the wages or earnings they have lost when they were unable to work because of their injuries. Accident victims also suffer from mental anguish and trauma. They need to be compensated for the pain and suffering they underwent as a result of the negligence of others. And for accident victims who died due to their injuries, their loved ones can file a wrongful death claim. Since the State of Georgia is an "at-fault" state, the amount of compensation that an accident victim will receive will be determined based on how much the other driver was at-fault. For instance, if the at-fault driver has been deemed to be at-fault for 70 percent of the accident, the said driver will need to compensate the victim for 70 percent of the damages sustained.
