The lawyer explains that nursing home abuse or neglect is the physical, emotional, sexual, or financial harm that is perpetrated against residents who are cared for in nursing homes or assisted living care facilities. Most

abuse and neglect cases are caused by the very people entrusted with their care and sometimes by other

residents.

Attorney Samantha Kucher adds that while both nursing home abuse and neglect result in harm to the elderly

individual, nursing home abuse varies slightly from nursing home neglect. Neglect is usually caused by an

unintentional lack of case, whereas abuse is intentional. Neglect also means a continuous and ongoing

failure to meet the needed care of the resident.

In the article, the injury attorney states, ?Because signs of nursing home abuse can vary greatly and are not

always easily discernible, family members must keep watchful for anything that may seem amiss when

visiting. Many signs of abuse can be dismissed because of the individual?s age or cognitive impairment.

Some residents fear saying anything and may even be too embarrassed to admit their abuse or exploitation

to their family.?
