Vehicular accidents in New York City have a one in five chance of causing injury. Although the number of car crashes in New York decreased in 2020, the number of injuries vehicular accidents caused increased. Brooklyn has the largest share of traffic accidents in 2020 of all boroughs, with a total of 35,245. Common causes include not following traffic instructions, distracted or impaired driving, and environmental hazards.

?After a car accident in Brooklyn, it can take a victim week, months, and even years to heal and get back

some semblance of normalcy. While some car accident injuries may only require minor medical intervention and a short period of healing time, some are physically and financially devastating to the accident victim and their family. Many of these accidents leave victims with serious injuries, enormous medical bills, time away from work, and, in the most catastrophic cases, life-challenging injuries or even fatalities, says the Brooklyn personal injury attorney.

Aside from vehicular accidents, the New York construction industry also contributes to the number of medical emergencies experienced by New Yorkers every year, according to attorney Kucher. Despite New York state having some of the most stringent labor laws in the country, Brooklyn construction sites see significant injuries each year, often caused by the negligence of property owners or contractors. In such accidents, attorney Kucher emphasizes that it is necessary to uphold the rights of victims and workers by ensuring they receive just compensation for their injuries.

In the case of the ordinary citizen, insurance policies cover any costs incurred should a person get into an accident. However, in some cases, insurance companies are reluctant to pay injury claims. Slip and fall accidents are another common cause of injuries in Brooklyn. Attorney Kucher explains that slip and fall accidents can result in serious injuries, especially when older people are involved. When a slip and fall accident occurs on another party's property, the property owner can be held liable for any injuries caused.

Attorney Samantha Kucher explains that "[a]lthough most slip and fall injuries are covered by insurance, insurance companies are very reluctant to pay these types of claims. Because slip and fall accidents can be complicated to prove, insurance companies will make it as difficult as possible for an injured party to get fairly compensated for their injuries."
