In the State of California, each driver involved in an accident will ultimately be given a percentage of fault by the jury, which is known as comparative fault. In some cases, 100 percent of the fault can be designated for one particular driver, with the other driver having 0 percent at fault. And in other cases, it may be determined that both drivers are equally at fault, which means each driver is assigned 50 percent of the fault. In other cases, the percentages may be divided with one driver more at fault than the other.

For those who were riding a motorcycle and got involved in accident, they will need to consult with an experienced auto injury lawyer near me Orange residents can depend on. What makes motorcycle accidents different is that the motorcycle rider has a much higher risk of getting seriously injured and may need to pay higher medical bills and may require a longer rehabilitation period, which means longer periods with loss of wages. The same problem can be experienced when involved in a truck accident because truck accidents tend to be more catastrophic, particularly for the driver of the car or motorcycle involved in the accident. Also, liability may not be limited to just the driver of the truck. Other potential defendants would be the trucking company, the employer, or the contractor.

An experienced personal injury lawyer would be able to prove that the company had some degree of control over the truck driver, and the accident happened while the truck driver was in their employment. However, this may not be case if the truck driver is an independent contractor of a bigger company. But the major factor would be the amount of supervision exercised by the larger company. Victims of a truck accident caused by the negligence of the truck driver may be entitled to certain damages, including financial losses from the medical bills, including the pain and suffering.
