As the clinic explains, plantar warts are small, fleshy growths that appear at the bottom of the foot. These warts, which may be rough or grainy, cause hard thickened growths and can cause a lot of pain when the affected person walks. While warts do often fade away on their own, it can take a lot of time to do so. In fact, according to the team of foot and ankle care specialists at Foot and Ankle Center of Iowa, it can even take years.

Plantar warts are caused by the HPV virus. The virus can enter the body through small cuts or other weak spots at the bottom of the feet, and since the HPV virus thrives in warm and moist environments, those who frequent locker rooms and swimming pools are very susceptible to being infected. Factors such as a previous history of warts, a poor immune system and other factors can also significantly increase the risk of plantar

warts.

Plantar warts are not a serious health concern, but they may still be painful. Therefore, the foot and ankle clinic says that it is wise to deal with them as soon as possible. Prior to the introduction of the SWIFT treatment, plantar warts were often treated with rather outdated methods. The most common methods for removing plantar warts, such as the use of salicylic acid, cryotherapy, chemo-based fluorouracil or bleomycin and surgical removal, can be painful, invasive and require multiple sessions to complete with a poor success rate.

This is not the case with Saorsa?s SWIFT technology. In the short time since it was introduced, SWIFT has established itself as a very reliable and effective option to deal with plantar warts. The SWIFT method uses state-of-the-art technology to deliver precise, highly controlled microwave energy into the affected area of the skin, and in doing so, stimulates the patient?s body into healing itself and fights the plantar warts at their source.

Since the SWIFT method uses microwave energy, the actual surface of the skin of the foot is not broken. The microwave beam simply penetrates up to a predetermined depth at which it can reach the root of the plantar wart. This ensures minimal debridement and results in a quick procedure (with sessions lasting between 5 to 10 minutes).
