Permanent maintenance is awarded in cases where the receiving spouse is not capable of self-support based on what they earned while married.

Spousal maintenance and, in some cases, child support can also be "reserved". This delays the discussion of the spousal support maintenance schedule to a later time and date to keep the divorce proceedings moving forward smoothly. It may require additional legal support.
