According to the Miami wrongful death lawyer, ?A personal representative files the wrongful death lawsuit on behalf of the surviving members. Every survivor?s family member that has an interest is named in the wrongful death lawsuit. Surviving family members can include the spouse, children, parents, and any blood relatives dependent on the deceased for support and services.?

Proving negligence is also necessary to hold the responsible party accountable for the wrongful death and to receive compensation for damages. First, the defendant must be proven to have owed the victim a duty of

care. In many cases, such a duty of care is implied. For example, every driver is expected to drive safely and reasonably.

The second matter to establish is the breach of the duty of care. The breach happens when a defendant acts negligently. If a driver has ignored their duty of care by speeding and a car accident happens due to their negligence, the driver could be held liable. Establishing causation for wrongful death is also necessary in building the case. The attorney mentions that it stands to reason that the breach of the duty of care must be determined to be the cause of the death to have a case.

?Finally, prove that the accident caused damage. Death is a very obvious loss. However, there are other possible damages for family members such as funeral and burial expenses and lost wages and earnings. Damages can often be both immediate and lasting,? explains the Florida wrongful death attorney.

Lastly, Attorney David Charlip recognizes that proving liability in wrongful death can be legally complicated and emotionally draining, especially after the loss of a loved one. The attorney emphasizes the importance of having an experienced wrongful death attorney when filing such a lawsuit.
