Some states may also award punitive damages depending on the severity of negligence that caused the death. These are damages awarded in addition to economic and non-economic damages as a punishment

for gross negligence and to deter others from taking the same actions.

The blog post elucidates that the plaintiff must establish negligence by clear and convincing proof, proving that the defendant's actions caused harm.
