Construction companies and property owners must adhere to the New York Labor Law. They must ensure that construction workers have a safe place to work at all times. You can sue for damages if your employer violates any code section. The special statutes Sections 200, 240, and 241 make contractors, owners, and agents liable for injuries sustained on construction sites, the Brooklyn construction accident lawyer says.

The lawyer mentions that the amount a worker may collect varies depending on the insurance coverage and the type of insurance. It is possible for construction managers, general contractors, and subcontractors to be held liable for any accidents that occur on a construction site. However, it can be difficult to determine. This is why it is important to seek the legal advice of an experienced attorney.

Attorney Samantha Kucher also explains that in a recent study by the Occupational Health and Safety Administration (OSHA), 66% of construction job sites in New York have violations. Injured workers usually have to face complicated situations because it is difficult to prove negligence in a construction setting.

In the article, attorney Kucher adds, "The situation varies from case to case. In some construction injury cases, the negligent party is the general contractor. In others, it might be the owner of the construction site. In yet other situations, both the general contractor and the site owner might have some liability under Sections 200, 240, and 241(6) of the New York State Labor Law."

Lastly, construction accident lawyer Samantha Kucher explains that having a skilled lawyer is very important in cases like construction accidents. An experienced lawyer may be able to help the victim receive the compensation they deserve.
