Workers could fall from high places if scaffolding is not done properly.

According to the Queens scaffold accident lawyer, "While workers' compensation can limit those who have suffered injuries on a job site from filing a lawsuit against an employer, New York labor laws require that construction workers are properly protected from injury on a job due to lack of scaffold safety. The failure of a contractor or property owner to abide by these laws allows an injured worker to hold the at-fault party responsible."

The lawyer explains that scaffolding is commonly required in the construction, maintenance, or demolition of buildings. There are specific laws in New York that protect workers' rights at construction sites. These laws require that scaffolding and all other materials must be in safe and good working condition.

Attorney Keetick Sanchez adds that New York City's scaffold law states that all owners and contractors involved in building, maintenance, repair, or reconstruction must provide the required equipment. The scaffolding law stipulates that scaffolding must be able to support at least four times the weight of all materials.

In the article, attorney Sanchez explains that the scaffolding law holds contractors and property owners responsible for the safety of workers on their construction sites. Workers who are unable to support the load or scaffolding frames that are not well constructed or maintained are at high risk for serious injuries, including fatalities, as well as falls.

"If you have been injured in a scaffold accident, you may be able to hold the responsible party accountable under New York's scaffolding law. If you are a family member of a loved one who has been killed in a construction accident, you may be entitled to a wrongful death claim," says the injury attorney

Lastly, the lawyer emphasizes the importance of having a skilled construction accident lawyer if they have been injured in a construction site accident. Having an experienced attorney may be able to help the victim receive the compensation that they deserve for the injuries they suffered.
