The lawyer explains that a protection order is often sought by someone who reports a domestic violence incident. Most of the time, a family court handles these types of orders. However, a criminal court may issue

temporary protection orders if the domestic violence situation includes stalking, sexual misconduct, and

sexual violence.

Attorney Edward Palermo says that domestic violence cases can cause a great deal of emotional turmoil not

only for the victim but also for the accused. People usually try to cool down over time and try to admit that the

allegations were untrue. However, despite this, an accuser is not allowed to withdraw from the case once the

police have filed the charges.

In the article, attorney Ed Palermo adds, ?The severity of the penalty usually depends on the type of

domestic violence charge. Disorderly conduct is one of the least serious domestic violence crimes. It is

classified as a violation. If you are convicted, the maximum sentence you can receive is 15 days

imprisonment and a \$250 fine. However, many domestic violence crimes are almost always misdemeanors or

felonies. If you are convicted, you could be sent to prison for multiple years.?

Lastly, attorney Palermo emphasizes the importance of having a skilled criminal defense lawyer when facing
