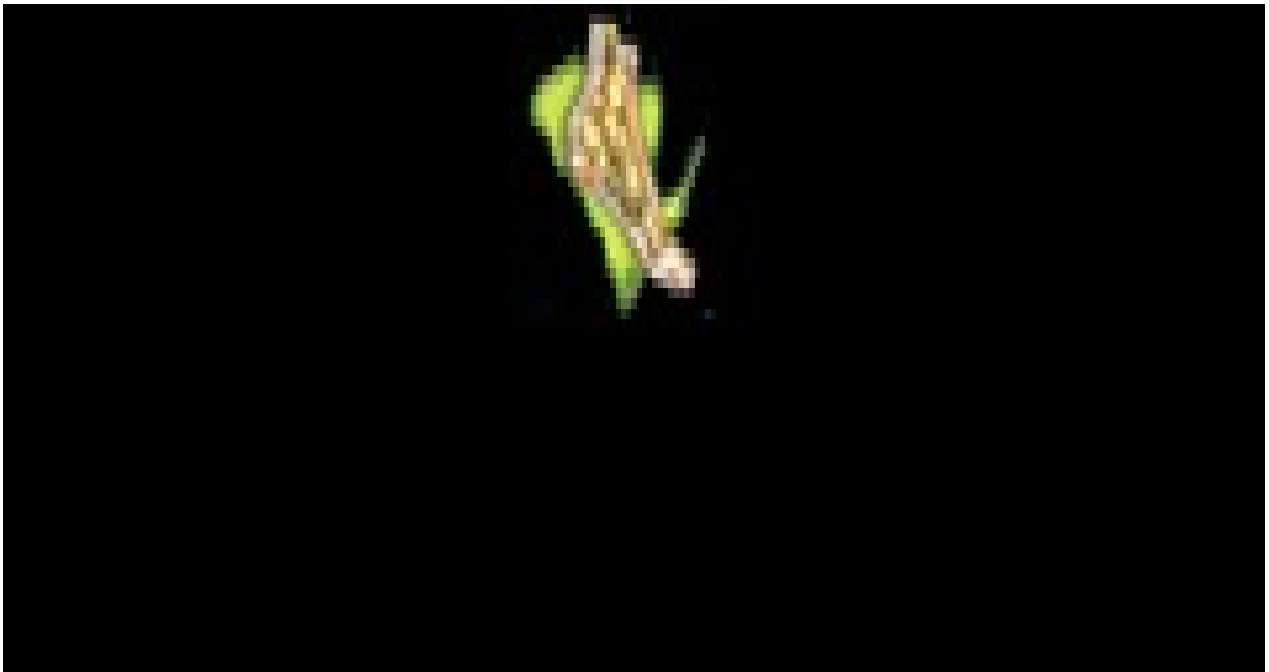




Podiatrist in Simpsonville SC Offers Plantar Warts Treatment with Saorsa Swift Wart Removal System

The Swift system is used to apply a small dose of microwave energy to the affected tissue in order to raise its temperature rapidly and thus activate the natural immune response. Plantar warts are quite painful because they are located on the soles of the feet and pressure is exerted on them when walking, running, or any activity that puts pressure on the feet. Plantar warts also have roots that

are deep inside the tissue, which makes them very difficult to treat with topical medication. And unlike laser therapy, cryotherapy, and other kinds of treatment that need to break through the skin to reach the wart inside, the microwaves can be programmed to penetrate to a certain depth and act directly on the affected tissue. No harm is done to the skin and to the neighboring tissue, which means there would be no need for bandages and dressings after the treatment session. Other than a brief pinch as the temperature of the affected tissue increases, the procedure is virtually painless and the patient can immediately return to his or her daily activities after the session.

And aside from being an effective treatment for plantar warts, the Saorsa Swift microwave therapy machine is considered to be safe. This is because it only applies a small dose of microwave energy that directly acts on the affected tissue. Nevertheless, some patients may need to consult first with their podiatrist or physician if they have certain conditions. These include: patients who are immune-suppressed; people who have a pacemaker; women who are pregnant or breastfeeding; patients who have conditions that affect the capability of the body to heal; those who suffer from poor circulation; and people who have metal plates or pins in their feet.

Meanwhile, aside from plantar warts, Upstate Podiatry Group also provides other kinds of services for foot and ankle related conditions. These include: Achilles tendon; ankle pain; ankle sprains; arthritic foot care; athletes foot; bunions; corns; diabetic foot care; EPAT (extracorporeal pulse actuation therapy); flat feet; foot and ankle surgery; foot orthotics; foot pain; fungal toenails; geriatric foot care; hammertoes; heel pain; heel spurs; ingrown toenails; joint pain (cartiva); neuroma (Morton's); plantar fasciitis; sports medicine; wound/ulcer care (stem cell grafts); and tendonitis (stem cell injections).

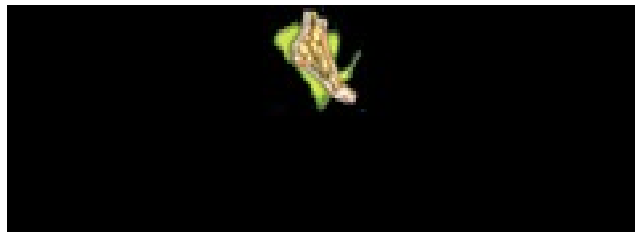
