In the United States, the Consumer Product Safety Commission estimates that slips and falls account for 2.7 million emergency injuries or around 12% of all hospital emergency room visits. The place and circumstances surrounding the accident can lead to it being litigated as a part of personal injury law or workers' compensation. Slip and falls are the leading cause of workers' compensation cases for employees who are 55 years and older.

On his blog, the Orange County personal injury attorney discusses some of the common causes of slip and fall accidents. Some of the biggest culprits are slippery surfaces, especially if there is no obvious indicator

such as a wet floor sign to convey that the floor is not safe to traverse. Obstructions such as uneven flooring, loose cabling, improperly stacked objects, unexpected protrusions, improperly secured rugs or carpets, and more, can trip even the most cautious individuals. Finally, people frequenting spaces with inadequate lighting arrangements, such as closets, parking lot extremities, staircases, and others, can also be prone to slips and falls.

From a legal perspective, if a person happens to injure themselves on property owned by another individual or group who is tasked with keeping the premises safe for guests, tenants, or workers, the injured party is liable to several different types of compensation. Slip and fall victims can seek reimbursement for their medical bills, lost wages due to the time required to recuperate, lawyer fees, mental distress, and even punitive damages if the court deems the accident to have been caused by repeated gross negligence on part of the accused.

Alexander Napolin discusses the requirements of a successful personal injury claim by saying, "For a successful legal claim, you must unequivocally prove that your injury was caused due to the negligence of the party who oversees the property you were injured on. There should be a preponderance of evidence to support that the defendant's dereliction of duty is to blame. You also need to bring the lawsuit within two years of the allegedly wrongful conduct. This may vary based on whether the defendant is a private party or a government body.
