Even if your blood alcohol level was .05%, you could still be facing severe consequences. Having a criminal conviction also follows you throughout life, affecting employment, career options, and even housing," says the Suffolk County DWI defense attorney.

The lawyer says that being charged with a DWI in New York does not mean that the person will be convicted right away. The state must prove the charges against that person first. Depending on the factors surrounding the person's arrest, the level of their blood alcohol concentration, and whether they had a combination of drugs and alcohol in their system.

Attorney Jason Bassett adds that DWI charges are criminal charges that should not be taken lightly. If a person has been charged with aggravated or felony DWI or has previous convictions, it is important they have a lawyer to fight for their rights. A skilled lawyer may be able to help the defendant seek a possible plea deal.

In the article, the lawyer says, "If this was a first DWI arrest, you may qualify to participate in an Impaired Driver Program designed to raise awareness about drunk driving to prevent future consequences. Those who

qualify can get a conditional license with a full license restored after the successful completion of the program.?

Lastly, DWI attorney Jason Bassett says that the courts can also look at other factors when deciding on a possible jail sentence. This can include whether there were other passengers in the vehicle (if an accident occurs) and whether there are children involved.
