The lawyer explains that there are serious injuries for victims of drunk driving accidents. These injuries include spinal cord injuries, traumatic brain injuries, fractures, internal organ damage, soft tissue injuries,

serious head and neck injuries, disfigurement, paralysis, burns, nerve damage, chronic pain, and wrongful death.
