According to the Miami Car Accident Lawyer, "Florida had 300,750 reported motor vehicle accidents in December 2020. More than half (187,218) of all accidents reported resulted in personal injuries and 2,809 people died in car accidents. The number of accidents in total decreased slightly between 2020 and 2019, but the total number of reported car accidents involving injuries is not consistent with a trend. Population growth and ongoing urban development could play a part in more crowded streets."

The lawyer mentions that the new motor vehicle laws and safety regulations in the state may have a positive impact on Miami drivers. These regulations include prohibiting using hand-held devices while driving, texting, and any other activities that may distract drivers. Florida is also home to four of the five most dangerous highways in the country.

Attorney David H. Charlip adds that victims of injuries must prove that the driver caused the crash because they were negligent in order to be eligible for compensation. Negligence means that the driver failed or was not able to drive safely. Each driver is legally expected to drive safely and with reasonable care.

In the article, attorney Charlip adds, "If a victim and her legal representative are able to prove that the other driver was distracted while driving, driving while impaired, or texting behind the wheel, they may be able to win the case. Another example of a breach of duty is negligently entrusting the control of a motor vehicle to an intoxicated person. At-fault parties in a crash are legally responsible for any injuries or financial consequences resulting from their negligence."
