Furthermore, the lawyer explains that it's very important to distinguish between a condo and a co-op when looking for a new apartment in Brooklyn, Manhattan, and anywhere in New York City. A condo purchase includes common areas, such as hallways and elevators. The lawyer adds that the biggest difference between the two is that when buying a condo, the buyer buys a title and not stock in a corporation.
