The lawyer mentions that possession of drug paraphernalia typically refers to equipment or accessories that are commonly used with drugs. These items include glass pipes, bongs, rolling papers, roach clips, syringes, capsules, spoons, plastic mini bags, and small measuring scales. There are also other factors that may be considered in determining whether or not the object is drug paraphernalia.

Attorney Adam M. Lustberg also explains that if a person is convicted of possession of drug paraphernalia, the penalties may include up to \$1000 in fines, jail time of up to 6 months, and driver's license suspension for 6 months up to 2 years. However, if the person is can prove that they really need to drive, a judge may waive the penalties on a driver's license.

ones, never look good on one's record and can result in the loss of your degree or job opportunities.?
