In the article, attorney Tafelski also lists tips about what a defendant should do with the allegations. The lawyer says that it is important to address underlying issues. Since it's not uncommon for domestic violence allegations to come from factors affecting a person's life, it is important that they try to address those issues in order to improve their life.

According to the defense attorney, "You should not talk about the domestic violence charges with anyone but your attorney. This prohibition included discussing the underlying incident, the circumstances of your arrest, the status of a PPO, and any other aspect of the case. Other people may become witnesses based upon these conversations, so keep the details to yourself."
