Residents should be allowed to interact with their fellow residents in order to keep their morale up. Other types of nursing home negligence include ignoring a resident's basic needs.

In the article, attorney Kucher adds, "Dehydration is a leading cause of injuries among nursing home residents. Their living quarters should be kept clean and at normal room temperature. Elderly residents should also have clean clothing and bedding. They should be bathed regularly. Failure to provide these basic things is considered nursing home negligence."
