The purpose of vision insurance plans, like VSP or EyeMed, is to assist patients with eye care, including the purchase of vision correction tools like glasses and contacts. While these plans differ from traditional health insurance, there are benefits for people considering laser vision correction such as extra treatments and discounts, depending on the nature of the plan.

There are also more significant vision insurance companies in the United States, such as Aetna, Blue Cross-Blue Shield, Cigna, UnitedHealth Group and Humana, all of which provide specific benefits for laser vision correction. This can include considerable discounts on laser vision correction treatments, usually in the range of 15% to 20%, increased savings of up to 50% on procedures carried out by surgeons in-network, benefits for non-prescription frames for sunglasses after vision correction and more.
