Attorney Keetick L. Sanchez also mentions that there are a lot of hazards and risks of injuries at construction sites. However, New York construction sites are frequently found to have dangerous conditions that go unnoticed and are deliberately ignored. This is why it is important to inspect construction sites regularly.

In the article, the accident attorney also says that in most cases, workers may not be able to sue their employer. New York workers? compensation laws are set out to protect employers from lawsuits should an employee suffer from injuries while on the job. However, depending on the circumstances surrounding the accidents and injuries, someone may be held liable for the injuries and the victim may be able to collect compensation for the injuries they suffered.
