By filing for a wrongful death claim, a loved one may be able to hold the negligent party accountable.

"A wrongful death claim is not intended to exchange money for the lost loved one or put an economic value on the grief the bereaved family is experiencing. Instead, it is a way to ease the financial impact of arranging a funeral or, potentially, the loss of a breadwinner," the Queens accident lawyer says.

The lawyer explains that New York law defines "wrongful death" as a death caused by a "wrongful act, neglect, or default". A wrongful death case is a type of personal injury case but the main difference from

other cases is that the decedent is no longer around so the representative of the decedent is the one filing the case.

Attorney Keetick L. Sanchez says that to establish that a wrongful death has happened, there are a few elements that must be proven. These elements include that the negligent party acted in reckless or intentional conduct that caused the death, that the decedent has surviving dependents such as spouse and children, and that the decedent's surviving dependents experienced financial hardship because of the death.

In the article, attorney Sanchez adds, "The evidence in the claim must be well-documented, especially the conduct of the negligent party. Admissible evidence in a wrongful death case can include medical records, autopsy reports, the negligent party's admission of guilt or statements, and video or audio recordings, among others."

Lastly, attorney Sanchez emphasizes the importance of having a skilled wrongful death lawyer when it comes to matters such as wrongful death claims. Having an experienced lawyer may be able to help the client understand their rights and receive compensation for the pain they suffered.
