Until recently, New York was one of the few states that did not require that those who worked on elevators be licensed or even properly trained or educated.?"

The lawyer explains that New York recently adopted the Elevator Safety Act which requires that everyone involved in the design and operation of an elevator should have a license. An advisory board was also

established to recommend regulations and best practices in inspecting New York's elevators.

Attorney Kucher also outlines the main causes of elevator accidents. These accidents include door defects where people could be trapped, sudden acceleration/deceleration or stops, elevator falls and misalignment, as well as falling into an unprotected shaft.

In the article, the accident attorney states that elevators and escalators are heavy machinery pieces that require hundreds of carefully-tuned mechanisms to work in harmony with one another. Users who are not aware of the dangers posed by any malfunction or breakdown of any of these mechanisms can be seriously injured.

Although the steps may seem simple and straightforward, proving negligence can be complicated. The building owner or controlling party and their insurance company may try to pin the blame on you for the accident.
