While there may be scaffold accidents that are unavoidable, some of them are caused by serious issues that remain unaddressed. These issues include missing safety guardrails, improper securing to the building, missing bracing, and many others.

In the article, attorney Sanchez also explains the New York Scaffold Law. This law helps protects workers who have been injured on a site because of safety problems. This law also holds contractors, owners, and agents liable when these accidents happen. If an accident occurs due to safety violations, multiple parties may be held legally and financially accountable for the worker?s injuries.
