equipment, construction workers could sustain serious or fatal injuries. Victims of accidents may be eligible for compensation if the owners, contractors, or workers are negligent in maintaining heavy equipment.

Attorney Keetick Sanchez also adds that heavy machinery is used often in construction and requires skill and training. OSHA has guidelines that can be used by workers to help them use machine parts. If these machines aren't used properly, they can cause serious injury.

Attorney Sanchez also addresses the dangers of heavy machinery on construction sites. Equipment malfunctions, overloading, poor inspection, and other hazards are all possible.

According to the lawyer, "Most injured construction workers in NY will be covered by workers' compensation insurance. Workers' compensation will cover the costs of injuries, regardless of fault. But there are some drawbacks to workers' compensation benefits. Workers' compensation is limited in the number of benefits and how long you can receive them. In addition, when you accept a workers' compensation settlement, you are waiving all rights of suing your employer."

Lastly, attorney Sanchez emphasizes the importance of seeking the help of an experienced heavy equipment accident attorney. Having a skilled attorney may be able to help victim understand their rights and receive the compensation they are entitled to.
