Attorney Samantha Kucher adds that negligence can also come into play if the owner or manager knew of the danger and failed to make the appropriate repairs. The National Safety Institute reports that falls are one of the leading causes of emergency room visits each year, accounting for over 8 million emergency room visits.

In the article, attorney Kucher adds that slip and fall accidents can also lead to serious and even devastating injuries. These injuries then cost the victim significant medical costs, lost time from work, and a long time of suffering from pain.

According to the Brooklyn slip and fall lawyer, "Slip and fall cases are protected under premises liability laws in Brooklyn and New York. These say that a person who owns or is in control of property must use reasonable care to keep the premises in a reasonably safe condition for the protection of all persons whose presence is reasonably foreseeable." When the party that is in control of the property fails to keep it safe, those who are injured have the right to hold them responsible for their damages."
