a claim and their legal team must also be able to prove that they have suffered physical (bodily), mental, or emotional (psychological) harm. He added that a personal injury claim also does not take into consideration any type of associated property damage. Most lawyers will also try to negotiate a favorable settlement but if that does not work a lawsuit can be brought before a judge. This August, GA attorney also mentioned that there are several types of compensation that a plaintiff can seek when bringing forth a personal injury claim. This includes reimbursement for medical expenses, loss of income, and other expenses that were a direct result of a personal injury. He says compensation may also be awarded for pain & suffering, loss of future income, future medical care expenses, canceled or altered plans, and because of awarded punitive damages.

The firm's founding attorney also talked about the different causes of personal injuries which often lead to people making a legal compensation claim. Among the most common which is injuries sustained in automobile accidents. He pointed out that car accident-related personal injury claims are a specialty of his law firm. Another common type of personal injury accident that was mentioned is slips & falls. These often occur when businesses, property owners, or tenants do not exercise reasonable care and that results in an injury to another person. Other types of personal injuries that often lead to legal claims being filed include assaults, medical malpractice, defamation, workplace accidents, defective products, and nursing home violations. Attorney Nugent noted that these are all areas of personal injury law where he is highly qualified to help an injured party pursue a claim.
