If you have been convicted of two serious traffic violations within three years, you face a CDL suspension of up to 60 days. Attorney Russ Kofman explains that if an individual is convicted of reckless driving for the first time, they may face up to 30 days in jail, a fine of up to \$300, and five points on their driving record. If a person is convicted of reckless driving for the second time, they may face a fine of up to \$525, jail time of up to 90 days, and five additional points on their driving record.

The defense attorney adds that if someone is convicted of reckless driving for the third time, they can be incarcerated for up to 180 days, pay a fine of up to \$1,125, and receive five more points on their driving record. The lawyer adds that it is important to seek the legal advice of a lawyer when facing these charges so that the defendant may be able to build a solid case and protect their freedom.

According to the article from the lawyer, "A reckless driving charge can have a huge impact on a person's life and finances. Fines for a reckless driving charge can be expensive. Similar to speeding, reckless drivers may be subject to jail time especially if they end up being involved in an accident in New York. If you are facing charges of reckless driving, you need to seek the help of an experienced attorney right away?"
