weapon.

Attorney Adam M. Lustberg says that firearms may only be transported in New Jersey under specific circumstances. These circumstances include if the person transporting the firearms is a licensed firearms dealer and is transporting the firearms during the course of the business. Another reason is if the person is transporting firearms between dwellings, a dwelling, and a business, or between a dwelling or business and a firearms repair shop.

Additionally, the gun crimes lawyer says that a person may also transport firearms if they are transporting firearms to a shooting range, hunting site, or a weapons exhibition.

The article also discusses who is allowed to purchase a weapon in New Jersey legally. According to attorney Lustberg, each state sets its own laws and guidelines regarding the purchase and possession of firearms in its state. In New Jersey, individuals under the age of 18 are prohibited from applying for any type of firearms license.

Criminal defense attorney Adam M. Lustberg says that any individuals who have been convicted of a domestic violence offense or are subject to a domestic violence restraining order are not allowed to own or possess a firearm. The same thing goes for individuals who are convicted of certain violent crimes or who have a history of conspiring to commit certain violent crimes.
