The lawyer mentions that a person is considered innocent until the prosecution has been able to prove their guilt beyond a reasonable doubt. There are also many defenses that a defense attorney may be able to use in a DWI case.

“Law enforcement does not have unlimited latitude when making traffic stops. Limits are placed on police authority to ensure individuals’ rights against unlawful search and seizure. Consequently, police have to operate within the limits of the law whenever making a traffic stop,” says the article from the Manhattan DWI lawyer.

The lawyer explains that there are three main categories of defense options that attorneys usually use when representing defendants of a DWI charge. These defenses include insufficient evidence to charge the

defendant, insufficient evidence to convict the defendant, and that there were procedural mistakes that negate the evidence.

Attorney Russ Kofman mentions that a law enforcement officer may be able to make a traffic stop if there is probable cause for them to believe that the driver committed a traffic violation. A police officer may also make a traffic stop if there is some form of equipment violation or if there is reasonable suspicion that a crime has been committed.

In the article, the attorney also adds that a traffic stop that is conducted unlawfully can invalidate the evidence that was collected. In such a case, going to trial will be a waste of time for the state, and the charges can be dropped.

Defendants in criminal cases are afforded important legal protections and procedures must be maintained in order to keep the system as fair as possible. If errors are made, they can derail the prosecution's case. There are times when there is simply no way to have DWI charges dismissed entirely. In these cases, the defense will look at other options, such as getting charges reduced to lessen the severity of the penalties, the defense lawyer adds.
