Hackensack Drug Paraphernalia Lawyer Adam M. Lustberg Explains Drug Paraphernalia Charges

The lawyer mentions that according to New Jersey law, it is illegal to possess a device, instrument, or drug paraphernalia used for unlawfully smoking, swallowing, or injecting a controlled dangerous substance.

According to the Hackensack drug paraphernalia lawyer, "Under New Jersey law, the offense of possessing drug paraphernalia carries severe penalties that could lead to significant jail time. Drug paraphernalia, which is typically found with marijuana, includes all products, materials, and equipment that are intended for use or designed for use in inhaling, consuming, injecting, storing, packaging, analyzing, testing, or preparing, can be any object or device used to inhale, ingest, inject, smoke, inhale, or otherwise consume illegal drugs."

The lawyer explains that for the district attorney to prove that the defendant is guilty, they must be able to

prove that the device, instrument, or drug paraphernalia for unlawfully injecting or smoking a controlled substance was in the defendant's possession. They must also be able to prove that the object's presence must be known to the defendant.

Attorney Adam M. Lustberg adds that the district attorney must also be able to prove that the defendant knew that it was an object intended for unlawfully injecting, smoking, or swallowing a controlled substance.

In the article, attorney Adam M. Lustberg adds that things that can be found inside a house can also be considered "drug paraphernalia" if they are used in a manner that facilitates illegal drug use. These everyday household objects usually include roach clips, needles, drug packaging bags, smoking pipes, spoons for liquifying drugs, and kits used for producing synthetic controlled substances.

"When you've been charged with possession of drug paraphernalia in New Jersey, you need an experienced criminal defense attorney who can battle your charges," the lawyer says.

Lastly, attorney Lustberg emphasizes the importance of having a skilled lawyer when facing charges of possessing drug paraphernalia. An experienced lawyer may be able to help the defendant protect their rights and their freedom.
