Over 33 percent of those occurred in seniors 65-75 years old. In a total of 90 of those events, the patients reportedly died.?

The lawyer mentions that FDA required that a second warning about Zostavax be added in February 2016. This warning should include a description of an eye condition called necrotizing retinitis. Multiple medical journals also reported that Zostavax can cause keratitis, which is a condition that can lead to permanent blindness.

Attorney David Charlip says that Zostavax has been linked to severe side effects, including blindness, painful rashes, and chickenpox. Anyone who has had adverse reactions to the Zostavax vaccine should seek immediate medical attention. A skilled Zostavax vaccine injury lawyer can also be very helpful if a lawsuit is required.

In the article, attorney Charlip adds, "Zostavax lawsuits have been filed across the country alleging that the Zostavax caused serious side effects, including the development of shingles and chicken pox.
