The lawyers mention that in New York, a person is guilty of forcible touching when they forcibly touch another person's intimate parts for the purpose of degrading or abusing that person or gratifying the defendant's sexual desires.

If a person is found guilty of forcible touching, he or she will be charged with a Class A misdemeanor. Forcible touching occurs without a person's consent when it results from any circumstance in which a person does not expressly or impliedly acquiesce to the actor's conduct, the Manhattan forcible touching lawyer says.

Attorney Russ Kofman adds that forcible touching includes squeezing, grabbing, pinching, rubbing, or other bodily contact involving the application of pressure to the victim's sexual or intimate parts. Forcible touching

also includes intentionally forcibly touching the sexual or other intimate parts of another person with the objective of just doing so.

The criminal defense attorney adds that the prosecution team will need to be able to prove three elements beyond a reasonable doubt. First, the prosecution must prove that the defendant touched the other person's intimate parts for the purpose of degrading or abusing them; second, the defendant performed the act intentionally with no legitimate purpose; and third, the prosecutor must be able to prove that the defendant forcibly touched the complainant without their consent.

If you are facing charges of touching someone forcibly, it is important to seek the legal support of an experienced criminal defense attorney.
