In California, surviving family members of the deceased party (or their estate) may sue for damages if the death occurred as a result of another party's wrongful actions. The firm points out here that this includes accidents and similar situations; the party that committed the act need not have done so with intent to harm for a wrongful death suit to be considered valid. They can be held liable for the death if their actions were negligent, reckless or intentional.

There are many reasons why a family would want to pursue such compensation (beyond the desire to seek

justice, as this is a civil procedure). For instance, the deceased party may have been the family's primary source of income, but this is far from the only reason for bringing a lawsuit. Most will be able to use a settlement for burial and funeral expenses, and the surviving family members' pain and suffering can be taken into account as well.

According to the firm, anyone who would be entitled to the deceased's property (under the state's laws on intestate succession) can bring a wrongful death lawsuit. This includes spouses or domestic partners, children or grandchildren and so on.

Napolin Accident Injury Lawyer states that several scenarios can fulfill the conditions required for a wrongful death lawsuit. In addition to assault and battery or murder and manslaughter, a wrongful death can occur as a result of an accident on the road, medical malpractice, elder abuse and even "slip and fall" accidents.

The firm clarifies that this is a non-exhaustive list, and they may not all lead to a wrongful death lawsuit. A slip and fall, for instance, has to be caused by another party's negligence to be considered. A property owner may be liable should they have had prior knowledge about a potential fall risk and then failed to address it in a reasonable manner (or adequately warn other parties of the potential risk). On the other hand, Napolin Accident Injury Lawyer says that one of the most common reasons for a wrongful death lawsuit is an accident on the road. This may involve a multiple-vehicle collision or a knockdown (where a pedestrian is struck by a vehicle). In fact, motor vehicle accidents are the most common cause of personal injuries in the country, with hundreds of thousands of people suffering injuries in the state of California alone. The immediate costs associated with such accidents can be astronomical, especially if the deceased received medical care for some time before passing away.
