The lawyers explain that scaffolding is often required in the building, maintaining, or demolishing of buildings.

There are specific laws in New York that help protect workers? rights on construction sites. These laws require that all scaffolding and other materials be safe and in good working condition.

Attorney Keetick L. Sanchez, the founder of the law office, also adds that the scaffold law in New York states that all contractors, owners, and agents in the construction, maintenance, or repair of buildings must furnish safe equipment for the necessary performance of the job. The scaffolding law also states that scaffolding must bear four times the maximum weight of materials that will be placed on it.

In the article, attorney Sanchez says that the scaffolding law makes the contractors and property owners accountable for the safety of those who work on their construction sites. When scaffolding frames are poorly constructed, not properly maintained, or cannot support the intended load, workers are at risk for serious falls, physical trauma, and fatalities.

According to the injury lawyer, ?If you have been injured in a scaffold accident, you may be able to hold the responsible party accountable under New York?s scaffolding law. If you are a family member of a loved one who has been killed in a construction accident, you may be entitled to a wrongful death claim.?

Lastly, the lawyer emphasizes the importance of having a skilled construction accident lawyer if they have been injured in a construction site accident. Having an experienced attorney may be able to help the victim receive the compensation that they deserve for the injuries they suffered.
