In addition to that, they will also be required to seek treatment from a medical provider that is approved by the Workers' Compensation Board and not their own physician.

Furthermore, work injury lawyer Keetick Sanchez says that someone may be compensated for their injuries, medical costs, or even family death benefits in the case of a fatality. However, workers' compensation benefits will not be able to cover non-economic costs such as pain and suffering or emotional distress.

The lawyer also adds that if someone is injured at work, they would want to pursue all the possible sources of compensation for their injuries. If the employer has valid workers' compensation insurance in place, the victim may not be able to file a personal injury lawsuit against them. However, if the employer doesn't or if the accident was caused by a third party, then it is possible to file a personal injury lawsuit.

Lastly, the lawyer emphasizes that if someone is involved in a workplace accident, it is important that they seek the help of an experienced work injury lawyer to help them receive their compensation.
