roads are narrower. Often, head-on collisions involve an element of recklessness where a driver swerves between lanes in order to overtake another car without checking for incoming traffic.

On busy roads such as the ones in Miami, a head-on collision accident can be very dangerous to both pedestrians and drivers. Multi-vehicle accidents often happen when multiple drivers are taken off guard due to a sudden driver maneuver. A head-on collision can happen when a driver suddenly veers into opposing traffic, leaving other drivers little to no room to avoid the impending crash.

In the article, attorney Charlip adds, "It is fairly easy to determine fault in a head-on collision as they often occur due to negligence. As they are caused by two vehicles from opposite directions colliding, one of them is assumed to be going the wrong way and is thus the liable party. The accident would not have happened if they were not going the wrong way."
