or wrongdoing to file a wrongful death lawsuit. A wrongful death claim can be brought against an individual, a company, or a government entity. It is a civil action that seeks to hold the responsible party accountable for the death of the victim and to provide compensation to the victim's family for their loss.

The damages that can be recovered in a wrongful death case may include medical and funeral expenses, lost wages and earning capacity, and the loss of companionship and support. The number of damages that can be recovered will depend on the specific facts of the case and the relationship between the victim and the surviving family members.

According to the lawyer, "Whatever the circumstances of your family member's passing, a wrongful death lawyer can help you explore your options for pursuing legal action. Although any act of negligence that leads to a fatality may fall under the definition of wrongful death, these incidents occur most often in car and motorcycle accidents, commercial trucking accidents, construction accidents, and many others."
