giving it away to someone else.

According to the estate planning lawyer, ?For a better result, consult an attorney right away. If the right strategies are used, Medicaid would count the inheritance to an extent, but not as much as it would have if the recipient had simply given away the whole sum. We know how to structure that person?s

financial arrangements, to protect the people to whom the person wants to leave his or her legacy.?
