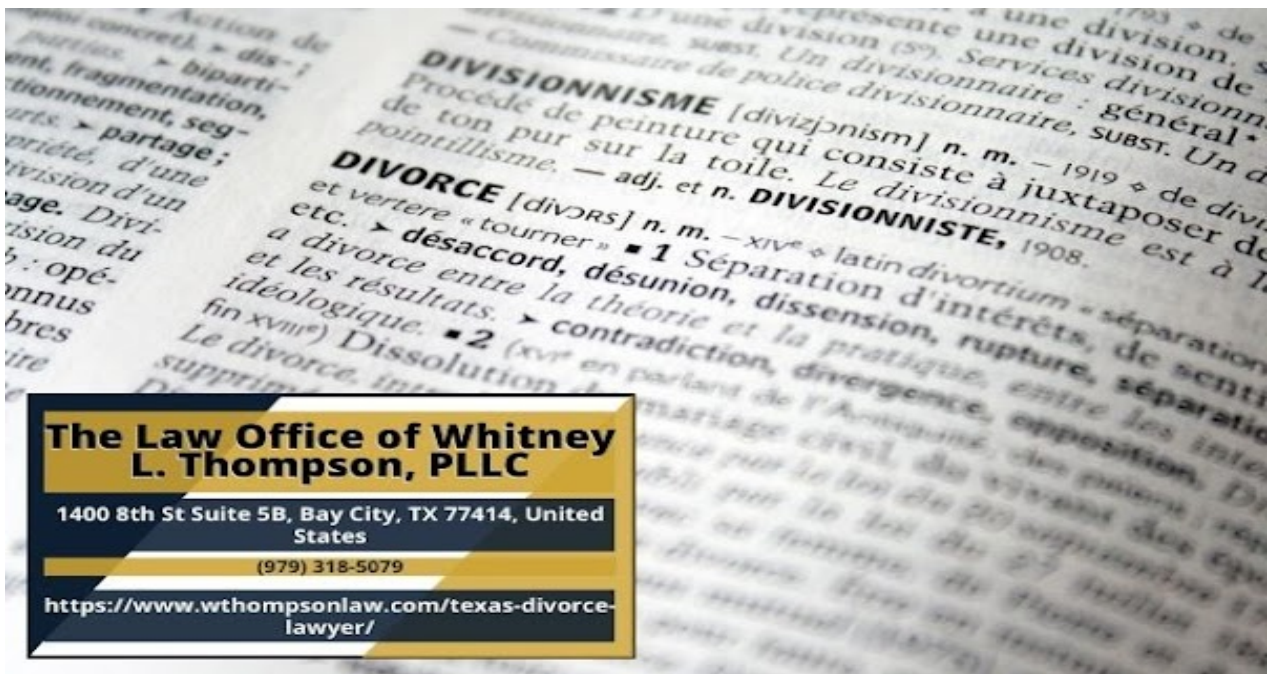




Bay City Divorce Lawyer Whitney L. Thompson Discusses Contested Vs. Uncontested Divorce in Bay City, Texas
