The lawyer mentions that cranes are the most dangerous equipment on any construction site.

According to the NYC crane accident lawyer, "Despite their own massive weight, many crane accidents are caused by collapsing or buckling under excess weight. Each crane is subject to stringent operating procedures and weight limits, but when construction contractors, supervisors, and owners ignore safety limits and operating procedures, it can mean serious injury or even death for those working on the site or in the vicinity."

In the article, attorney Sanchez states that approximately 45 percent of all crane accidents are due to booms

or cranes coming into contact with energized power lines. Unsafe crane use, overloading, crane failures, miscommunication between workers, and negligent construction supervision can all contribute to crane accidents.

Attorney Keetick Sanchez also discusses the most common injuries sustained in crane accidents. These injuries can include fractures, burns and chest injuries, back injuries as well as amputations, degloving, paralysis, spinal cord injuries, internal bleeding, and organ damage.

The crane accident lawyer mentions that sometimes injuries caused by crane accidents can cause serious injuries and even death. The lawyer also states that victims of crane accidents may be eligible for compensation. If the victim was a worker on the site, workers' compensation benefits may be available for them.

Attorney Sanchez mentions that negligence can result in a crane accident. In such cases, the responsible party would be responsible to pay all expenses. The relatives should not have to pay funeral and medical expenses if the injury is serious.

Lastly, the accident lawyer explains that if someone is a victim of a crane accident, they should seek the help of an experienced accident lawyer right away. Having a skilled lawyer may be able to help the victim receive the compensation they deserve.


