Thus, when there is a need for a case to be moved to the court system, the very first thing that the separating parents are advised to do is attend a parenting class and then attend mediation to try and resolve their issues. Only when these efforts have been exhausted will the case be transferred to a court hearing.

The lawyers at Camino Law are also ready to help with separation and divorce. In North Carolina, it is a requirement for the couple to live apart and separately for one year before they can file for divorce. There is no paperwork required for the couple to declare themselves separated but they must live in different homes, and not just in separate rooms to be considered separated.
