

Zofran Lawsuits Consolidated Into MDL 2657 - Free Legal Consultation And Checklist Available To Mothers Of Children With Birth Defects

More than a hundred Zofran birth defect lawsuits have been consolidated into Multidistrict Litigation, i.e., MDL 2657 through the middle of November. And the number is growing quickly.

Women who took Zofran during their pregnancy and whose children have subsequently suffered birth defects need to know information on how best to file their own Zofran compensation lawsuits.

Some women who have not yet filed a lawsuit may wonder if they are still eligible to do so. According to attorney Wayne O'Bryan, the coordinator of the Medical Compensation Help Team, they can indeed still file and join the multidistrict litigation MDL 2657.

In fact, O'Bryan says, they should. Any woman who took Zofran during her pregnancy and then had a child who suffered birth defects may be eligible for compensation - and joining the MDL 2657 multidistrict litigation will optimize her chances of getting it.

That's because multidistrict litigation is a special federal procedure intended to speed up the process in which complex cases are handled. To ensure the most successful outcome, any affected woman should seek legal advice as soon as possible.
