As soon as possible, it is also essential to have the injuries examined and treated by a doctor. This should be done even if the discomfort or pain is mild because some car accident injuries may take weeks to fully become evident. The medical bills, doctor's notes, and other documentation can be used in the case later on. Most of all, it is vital to monitor all expenses that are related to the auto accident and place all of the notes and documents in one location. These should include the claim number, name of the insurance adjuster, all medical documents and bills, estimates for repairing the car damage, and names and contact information of all relevant parties.
