

# SUBSTANCE ABUSE

Substance abuse (also known as drug abuse) is a patterned use of a drug in which the user consumes the substance in amounts or with methods which are harmful to themselves or others, and in a form of substance-related disorder. Widely differing definitions of drug abuse are used in public health, medical and criminal justice contexts. In some cases, criminal or anti-social behavior occurs when the person is under the influence of a drug, and long-term personality changes in individuals may occur as well. In addition to possible physical, social, and psychological harm, use of some drugs may also lead to criminal penalties, although these vary widely depending on the local jurisdiction.



## COST



### EUROPE

The UK has reported by 10 countries categorized according to the functions of government. Overall, the highest proportion of this total came within the government functions of Health (60%) (e.g. medical services) and Public Order and Safety (POCS) (20%) (e.g. police services, law courts, prisons).



### UNITED KINGDOM

The UK Home Office estimated that the social and economic cost of drug abuse in the UK economy in terms of crime, absenteeism, and sickness is a total of £2.3 billion a year. However, the UK Home Office does not estimate what portion of those crimes are unintended consequences of drug production and distribution, nor what is the cost of enforcement.



### UNITED STATES

These figures represent overall consumer costs, which can be divided in three major categories: health care, enforcement, and productivity losses.

Health-related costs were projected to total \$16 billion in 2002. Productivity losses were estimated at \$128.6 billion. In contrast to other costs of drug abuse (which involve direct expenditures for goods and services), this value reflects a loss of potential earnings for workers in the labor market. The total cost of drug abuse has been performed about the impact of drug abuse on the economy. The total cost of drug abuse is estimated to be \$144.6 billion.

The non-health care expenditures primarily concern costs associated with the criminal justice system and crime victim costs, but also include a modest level of expenses for administrative costs of the judicial system. Another \$6.6 billion was spent for state judicial police protection, followed by \$6.2 billion for federal supply reduction initiatives.

It is important to ascertain that that dual diagnosis treatment program is backed by evidence and is properly accredited and licensed. There should also be an after care program to help the patient avoid relapse.

Meanwhile, rehab programs may vary in duration. Some are 30 days long while others may be 60 days long. Oftentimes, 30 day inpatient addiction programs may be preferred. The 30-day rehab program is usually a good starting point for individuals struggling with an addiction. This is useful particularly for people who are initially disinclined to make a long term commitment and 30 days is a short enough length of time for them. Nevertheless a 30-day rehab program will not be a shortcut. It offers sufficient time for the person to adjust to a sober lifestyle and to think more clearly. This allows them to make good decisions that may even help them want to extend the length of the treatment

Naturally, the 30-day rehab program is less costly compared to the longer-term rehab programs. The cost may range from \$400 to \$900 per day, which would mean a total of \$14,000 to \$27,000, depending on the luxury level of the facility and the level of care provided.
