To provide people an idea of the amount they may be able to claim, they offer information on the outcomes of some of the firm's recent cases. These include: \$2 million award for jogger struck by SUV driven by a teenager; \$1.8 million for a man injured in an accident with a teen driver; \$1.25 million awarded to a victim of a distracted driver; \$700,000 award to an Indiana woman injured in a rear-end truck crash; \$250,000 maximum policy limit obtained for a woman struck by a car.
