Premises liability involves property-related accidents resulting from the negligence of property owners. There are a number of factors that can affect whether or not a slip and fall case should be pursued or not. One important question is whether the person filing the lawsuit had suffered any major injuries due to the fall. The case may not be worth pursuing if the accident victim was not hurt or was simply bruised or the injury was slight. Second, it is essential to be able to show that the property owner or manager was negligent and was aware of the hazardous situation. For instance, the owner knew there was a wet floor on the premises but did not place a warning sign to make people aware of it.

It is important to note that premises liability lawsuits are extremely time-sensitive sophisticated and time-sensitive. The statute of limitations in Missouri limits the time when the accident victim is able to file a lawsuit to a maximum of five years from the date of the incident. The slip and fall accident attorney must also be able to demonstrate a number of factors. One is that the property owner or manager created a dangerous situation that resulted in the injuries. Second, the property manager or owner knew about the dangerous condition but failed to provide the necessary remedy. Third, visitors were not sufficiently warned about the hazardous condition by the property owner or manager, such as putting up wet floor signs.
