Justin Sparks says, "Texas is an open carry state, but there are still a number of Federal and Texas laws regulating firearms. Obtaining a handgun license in Dallas/Fort Worth is fairly simple, but whether or not you have a License to Carry (LTC), you should be familiar with the laws and regulations on carrying and transporting a firearm. You need a firearms attorney that can defend you when the you are facing a violation of your right to carry and use a firearm."

It is important to note that while the 2021 Legislature had approved Constitutional carry of handguns, a person's right to carry is not unrestricted. There are limitations on where and when a person can carry a firearm. Those who have an LTC actually have more responsibility with regards to carrying a firearm and, if not done correctly, that person can be arrested for illegally carrying of a firearm.

Even if a person is licensed to carry a firearm, there are certain locations where people are not allowed to enter with a firearm, club, illegal knife, or any prohibited weapon. These include: a high school, collegiate, professional or interscholastic event (but a licensed person can carry unless signage is posted); civil commitment facility; correctional facility; hospital or nursing home (but a licensed person can carry there unless signage is posted); mental hospital; amusement park (but a licensed person can carry there unless signage is posted); meeting room of a governmental entity during a scheduled open meeting unless the person has a license to carry; school or educational institution; polling place during the day of election or early voting; courts and offices used by a court; secured premises of an airport; racetrack; within 1000 feet of a place of execution; and alcohol license premises (but a licensed person can carry there unless signage is posted).
