There are a number of goals in a pre-charging investigation. These include: preventing the filing of charges; reducing the charges; helping with self-surrender, arranging release conditions, and avoiding arrest; diverting allegations into an informal disposition, and ensuring clients are advised of their legal rights.

During the pre-charging investigation, the criminal defense lawyer can enhance the credibility of his client or reduce the credibility of the complaining witness. Some of the usual ways of increasing the credibility of their client is to inform the prosecutor about favorable evidence and/or polygraph results. Attorney Dodell says, ?By providing favorable evidence or witness statements to the prosecution, it is possible to challenge or question the complainant?s side of the story, or his reputation for truthfulness, making it possible to prevent the filing of charges.?
